Paratransit Service

All of our P.F.M.T. buses are lift-equipped for wheelchairs and/or other mobility aids and may be accessed at any designated P.F.M.T. stop. For any passenger who is unable to get to a designated trolley stop, a paratransit van may be scheduled for a next-day pickup. Paratransit van reservations may be made by calling 865-453-6444. Our paratransit van service is an origin-to-destination service for the mobility impaired resident or visitor staying anywhere within the city limits of Pigeon Forge or anywhere within 3/4 of a mile of any P.F.M.T. route, whichever applies. Permanent residents planning on using the paratransit van service must submit an ADA Paratransit Eligibility Application to the P.F.M.T. Office, 236 Old Mill Avenue, Pigeon Forge, TN, 37863. These application forms are available at the same location. The certification process shall be waived for visitors staying in the area for any combination of 21 days during a 365-day period. Drivers are permitted to assist the wheelchair passengers on and off the lifts, as needed. All wheelchairs and mobility aids are required to be strapped down (secured) while on the P.F.M.T. or paratransit vans. The paratransit van fee is \$1 per person each way. (One personal-care attendant shall be permitted to ride free of charge while accompanying a passenger with limited mobility.) Information on the P.F.M.T. routes will be provided in large print upon request to the P.F.M.T. office.





Pigeon Forge Mass Transit

All trolleys depart from and return to Patriot Park, 236 Old Mill Avenue.

NORTH PARKWAY

The North Parkway trolley travels east to Teaster Lane, on to Veterans Boulevard, to the Parkway. Traveling north on the Parkway through Pigeon Forge, continuing to the Governor's Crossing/Walmart area of Sevierville.

*Arrives every 20 minutes.

SOUTH PARKWAY

The South Parkway trolley travels east to Teaster Lane, then north to Jake Thomas Road, stopping at LeConte Event Center. Continuing south on the Parkway, the trolley turns on to Pine Mountain Road, before returning to the Parkway, the trolley continues south to the city limits, serving area campgrounds and Dolly Parton's Stampede.

*Arrives every 20 minutes.

GATLINBURG WELCOME CENTER

This trolley travels non-stop to and from the Gatlinburg Welcome Center, located on the spur just outside of the city limits. Hours of operation are subject to the schedule of Gatlinburg's city trolleys.

*Arrives every 30 minutes.

DOLLYWOOD

The Dollywood Trolley travels continuously to and from Dollywood, running 30 minutes prior to the park opening. After the park closes, the trolley transports guests until everyone has returned to Patriot Park.

*Arrives every 15 minutes.

DOLLYWOOD'S SPLASH COUNTRY

This trolley loops continuously between Patriot Park and Dollywood's Splash Country.

*Arrives every 20 minutes.

WEARS VALLEY

Traveling north on Teaster Lane, this trolley passes by Mountain Mile Mall to traffic light #2. Then continues to Community Center Drive and Sand Pike Boulevard, then proceeds to Wears Valley Road, servicing area campgrounds and other businesses west of the city.

*Arrives hourly.

*All arrival times are approximate and may be delayed considerably during high traffic times, including car shows, parades, holidays and other special events.
